



**SUPPLEMENTARY REGULATIONS**  
**2019 “Mantic Clutch NSW Hillclimb Championship”- Round 3**  
**CAMS PERMIT #119/0704/02**

1. THE EVENT will be held under the FIA International Sporting Code including Appendices, the National Competition Rules of CAMS, the Speed Standing Regulations, the CAMS 2019 NSW Hillclimb Championship Sporting Regulations, these Supplementary Regulations and any Further Regulations that may be issued and approved by CAMS. This Event will be conducted under and in accordance with CAMS OH&S, CAMS Safety 1st and Risk Management Policies, which can be found on the CAMS website at [www.cams.com.au](http://www.cams.com.au).

2. THE EVENT will be held on: **6<sup>th</sup> – 7<sup>th</sup> April 2019**. At: **Fairbairn Park**, Sutton Road, ACT.

3. THE EVENT will be conducted as a **State Hillclimb Championship** Round Event under CAMS Permit No: **119/0704/02** which has been issued and will be displayed at the event.

4. THE EVENT will be organised and promoted by a Committee from:

5. THE EVENT will include as a minimum **4 runs** of: **SDMA Hillclimb** as per the CAMS Hillclimb Regulations.

8. ENTRIES: Open on publication of these Supplementary Regulations and **close at 8 p.m. on Friday 27<sup>th</sup> March 2019**. **No late entries will be accepted.**

a) Maximum number of Driver entries for the Event: 60 Reserves: 6

Reserves will be utilised if a Driver does not turn up at the Event, has not paid the prescribed Entry Fee by the Closing of Entries or fails Scrutiny. The Organiser reserves the right to refuse entry to any Competitor in accordance with NCR 83 of the current CAMS Manual of Motor Sport.

9. ENTRY FEE will be: **\$125.00** (Junior \$85). **Practice on Saturday: \$50.00.**

All monies are to be paid before the Close of Entries.

### 10. MINIMUM LICENCES:

Current CAMS Level 2S/2SJ Licence or above. Competitors must produce a valid and current CAMS Competition Licence and Club Membership Card of a CAMS-Affiliated Car Club and Log Book (if issued) at document check.

### 11. EVENT FORMAT:

SCRUTINY will be held at: **Scrutiny Bay from 10.00 a.m. Saturday and continue throughout the day finishing at 4.00 pm and prior to the event Sunday from 7:05 am. Practice will be available from 12.00 pm to 4.00pm Saturday.**

a) All vehicles must comply with Schedules A & B of the CAMS General Requirements for Automobiles (as specified in the current CAMS Manual), including a fire extinguisher (Schedule H of the current CAMS Manual); blue triangle (for battery) and a secondary method for fastening the bonnet.

b) Maximum noise limit: **95 dba** at: 30 metres. Any vehicle found to exceed the maximum noise emission limit will be suspended from the Event until the Chief Scrutineer and Clerk of the Course are satisfied that action has been taken to bring it within the limit. An effective physical change to the vehicle will be required by hardware changes or software settings before approval can be given for the vehicle to run again at the event. If a vehicle is deemed to have exceeded the noise limit on a particular run, no result will be entered and the vehicle will be disqualified for that run. For the purpose of the results, only those runs in which the vehicle conformed to the noise limit will be allowed.

c) **Competition numbers** are to be positioned on both sides and on the front of the vehicle.

d) Drivers and vehicles must be presented in a clean and tidy manner. Note: The Event will not be delayed due to late arrivals. It is the drivers' responsibility to ensure their vehicles are scrutineered before the scheduled starting time of the Event. Drivers must attend Scrutineering personally so that their driving apparel can be checked.

For those cars that are in the Targeted Scrutineering System, the Competitor must present the log book to the Scrutineers and sign the Declaration Form. For cars that are at the fourth meeting or 12 months since and audit, an audit will be required, the Scrutineers will advise when and where this will be done.

**DRIVERS' BRIEFING** will be held: at: **The Start Line at 8:30 am Sunday.** It is compulsory for **ALL Drivers to attend.** Scrutiny will cease whilst the Drivers' Briefing is in progress.

Note: A Driver **"sign-on" sheet must be signed by all Drivers** to prove Briefing attendance, failure to sign on may result in penalties being applied by the Stewards of the Meeting.

**The EVENT commences at:** 9.00 a.m. and finishes by: 5.00 p.m. Practice will be available from 12.00 noon Saturday.

### 12. VEHICLE CATEGORIES AND CLASSES:

As per the current CAMS Manual for championship registered competitors. The organisers may re-classify any vehicle if they believe it is not eligible for the category/types or class in which it has been entered. Where restrictors are applicable, turbochargers may be inspected to confirm compliance with CAMS category rules and additional classes as per the NSW Hillclimb Championship Rules.

The Organiser may re-classify any vehicle if they believe it is not eligible for the category / type or class in which it has been entered.

Non log booked cars compete in a non-championship class.

## SUPPLEMENTARY REGULATIONS (CONT.)

**13. FUEL:** All Competitors are permitted to use any fuel as defined in Schedule G in the current CAMS Manual of Motor Sport. **Vehicles running on alcohol** shall have signage indicating the use as is prescribed in Schedule G Item 5.3.

### **14. DRIVER SAFETY:**

Drivers must wear apparel as outlined in Schedule D of the current CAMS Manual of Motor Sport, including:

- a) a helmet that complies with AS1698 or better (as per the current CAMS Manual of Motor Sport) and carries marking to that effect, or is otherwise specifically approved by CAMS.
- b) non-flammable clothing, including cover from throat to wrists to ankles (apparel of **nylon or similar** material is forbidden). Flame retardant overalls, or better, are highly recommended.
- c) suitable **flame retardant footwear** (thongs, open sandals, high-heeled shoes and **nylon joggers** are forbidden), and
- d) in open cars, goggles or a visor with a lens material other than glass (to AS1609) are mandatory as are leather or Nomex gloves which entirely cover the hands.
- e) The SDMA strongly recommends that convertible vehicles (whether road registered or not) be fitted with a ROPS. It is further recommended that such vehicles compete with the soft top down and the driver wear appropriate protection in accordance with d) above.

**15. REPLACEMENT VEHICLES:** At the sole discretion of the Clerk of the Course, a Driver whose vehicle has broken down may use a replacement vehicle. The replacement vehicle must have been scrutineered, and preferably be in the same category/type and class as the original vehicle. Where the original vehicle has recorded a time and the scrutineered replacement is not in the same category/type and class as the original vehicle, the replacement vehicle will not be eligible for prizes and/or trophies.

**16. TIMING EQUIPMENT** will be: with an accuracy of: **0.01 second (1/100<sup>th</sup>)**

**17. RERUNS:** Reruns will be permitted at the sole discretion of the Clerk of the Course. A restart will only be permitted if the rear wheels have not crossed the start line, if a red flag is displayed on the hill or a miss time occurs. If required it cannot be run before 5 other vehicles have had their runs.

**18. PENALTIES:** Any Competitor deemed by the Stewards to be using the concrete braking area from Turn 3 to Turn 5 and missing Turn 4 during a timed lap will incur a penalty. The penalty will be removal of the time for that run from the Event.

**19. AWARDS** will be presented at: Pitstop Cafe area as soon as possible after the last run. Awards as per CAMS 2018 NSW Hillclimb Championship Sporting Regulations.

a) Pointscores: Outright and Class pointscores shall be:

1st - 14 pts	2nd - 11 pts	3rd - 9pts	4th - 7 pts	5th - 6 pts
6th - 5 pts	7th - 4 pts	8th - 3 pts	9th - 2 pts	10th - 1 pt

b) **Round** awards shall be made for 1st to 3rd Outright, a Junior and a Lady's award. Class awards shall be determined according to the number of Competitors competing in a class or category

- i) Up to 3 - trophy for 1st Place only.
- ii) Up to 4 - trophies for 1st and 2nd Places.
- iii) Up to 5 or more - trophies for 1st, 2nd and 3rd Places

c) In the event of a tie on points, drivers shall receive equal awards.

d) Registered Competitors using a Non Log booked car, with **full** Road registration, are eligible to score points in the championship in the classes nominated *and other classes within the Championships*.

## SUPPLEMENTARY REGULATIONS (CONT.)

e) Other Competitors with Non log booked cars are permitted to compete, at the discretion of the Organisers (See Sporting Regulation, Article 2), but they will not be eligible to score points in the Championship.

**20. AUTHORITY OF OFFICIALS:** Any Driver not following a reasonable instruction by an Official during the Event may be excluded from the Event at the discretion of the Stewards of the Meeting.

**23. INSURANCE:** Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at [www.cams.com.au](http://www.cams.com.au).

**24. PROTESTS:** Any protests must be made in accordance with Part XII of the current NCR's.

**25. POSTPONEMENT/ABANDONMENT/CANCELLATION:** The Organisers reserve the right to postpone, abandon or cancel the Event in accordance with NCR 59 of the current CAMS Manual.

**26. ALCOHOL, DRUGS AND OTHER SUBSTANCES:** Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

The CAMS Anti-Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such. In any areas where the National Competition Rules and the Anti-Doping Policy conflict, the Anti-Doping Policy will apply.
